Section 7 - Preventative Measures

Personal Protective Equipment: Avoid contact with eyes. Wear safety goggles with side shields. It is generally recognized that contact lenses should not be worn when working with chemicals because contact lenses may contribute to the severity of eye injury.

Respiratory protection: A respirator is not required if this product is used with adequate ventilation.

Ventilation Requirements: General room ventilation is adequate.

Other Measures: An eyewash and safety shower should be located nearby and ready for immediate use.

Action to take for spills & leaks: Wear chemical protective clothing, rubber gloves and suitable respiratory protection. Small spill area may be flushed with large quantities of water. Larger spills may be contained by diking. Comply with all government regulations on spill reporting, and handling and disposal of waste.

Storage & Handling Precautions: Keep container away from excessive heat, sparks and flames. Store in a cool, dry, well ventilated location. Do not store product near incompatible materials. Warning, causes eye irritation. Avoid contact with eyes and repeated contact with skin and clothing. Do not ingest. Keep container tightly closed when not in use. Do not use pressure to empty container. Wash thoroughly after handling. Use with adequate ventilation.

Repair and Maintenance Precautions: Do not cut, grind, weld or drill in, on or near this container.

Other Precautions: Containers, even those that have been emptied, will retain product residue and vapours. Always obey hazard warnings and handle empty containers as if they were full, and dispose of in an approved manner.

Section 8 - First Aid Measures

If inhaled: Remove victim to fresh air. Give artificial respiration if not breathing. Get immediate emergency medical attention.

In case of eye contact: Immediately flush eyes with clean water for at least fifteen (15) minutes, lifting the upper and lower eyelids occasionally. Get immediate emergency medical attention.

In case of skin contact: Flush skin with plenty of clean running water for at least fifteen (15) minutes. Remove contaminated clothing and shoes. Wash and launder clothes before re-use. If irritation persists after washing, seek medical attention.

In case of ingestion or swallowing: If victim is conscious and medical attention is not immediately available, dilute stomach contents by giving large amounts of water or milk. Do NOT INDUCE VOMITING. Never give anything by mouth to an unconscious victim. Get immediate emergency medical attention.
